We look forward to having your child participate in this innovative program and take advantage of this unique opportunity to receive instruction from some of the best jazz musicians on the scene today. Before registering your child please review the following requirements:

Participant is between the ages of 10 - 18 years old.

Participant will bring their instrument to the program. Exceptions include piano and drums (please bring sticks).

Participant is well behaved and not disruptive to the class or they will be asked to leave.

Participant is able to attend all the sessions, as each day builds on the next. The program is Monday - Friday June 24th - 28th, 10am - 2pm.

Parent/guardian is able to be reached by phone at all times while the child is attending the program. Parents are invited to stay and watch if they would like and if not should arrive at Moody's at 1:45 for pick up. Please do not be late. There is a sign-in and sign-out procedure that is required every day.

Moody's will serve lunch every day. We are not able to meet individual dietary needs so if your child has any dietary restrictions please pack a lunch for them.
